

Section A (one document is required)	
Pay Stub	Issued less than forty-five (45) days prior to consideration of residency Contains student name, shows his or her District of Columbia residency and shows income tax withholdings
Financial Assistance from the Government of the District of Columbia	Official documentation of financial assistance from the Government of the District of Columbia and issued to the person enrolling the student within the past twelve (12) months, including, but not limited to Temporary Assistance for Needy Families (TANF), Medicaid, the State Child Health Insurance Program (SCHIP), housing assistance or other programs
Supplemental Security Income Annual	Supplemental Security Income annual benefits notification issued to the person enrolling the student within the past twelve (12) months and indicating his/her current DC home address
A Tax Information Authorization Waiver Form	A tax information authorization waiver form certified by the DC Office of Tax and Revenue, with the name of the person enrolling the student and evidence of payment of DC taxes for prior tax year
Military Housing Orders	Military housing orders and residency verification letter or DEERS statement showing the student's name, the name of the person enrolling the student, and their current DC home address
Proof that the child is a ward of the District of Columbia	Proof that the child is a ward of the District of Columbia, in the form of a court order
Embassy Letter	Embassy letter, with an issue date after April 1 of the current school year, showing the name of the person enrolling the student, a statement indicating that the person enrolling the student lives on embassy property in the District of Columbia, and an official embassy seal
Section B (two documents are required)	
Unexpired DC Motor Vehicle	DC motor vehicle registration showing the name of the person enrolling the student and his/her current DC home address
An Unexpired Lease or Rental Agreement	An unexpired lease or rental agreement and <u>with</u> receipts for payment or cancelled checks for payment of rent for a period within two (2) months immediately preceding consideration of residency), for the current DC address at which the student actually resides
An Unexpired D.C. Motor Vehicle Operator's Permit	An unexpired D.C. motor vehicle operator's permit or official government issued non-driver identification in the name of the person enrolling the student showing his/her current DC home address

<p>One Utility Bill</p>	<p>One utility bill (only gas, electric, and water bills are acceptable) with the name of the person enrolling the student, current DC home address, and <u>with</u> receipt of payment or cancelled check for payment of the bill. The receipt of payment or cancelled check must be from a period within the two (2) months immediately preceding consideration of residency.</p>
<p>Section C (Others)</p> <p>(If able to provide only one document from section B, one of the documents listed below is acceptable as an alternative document)</p>	
<p>Official Correspondence</p>	<p>Official correspondence from the District and/or federal agencies (USCIS, Social Security, etc.) dated within 45 days of enrollment</p>
<p>Court Documents</p>	<p>Court documents within six months of enrollment</p>
<p>Bank Statements</p>	<p>Bank statements documenting the student's address over the past two (2) months</p>
<p>Letter From Employer</p>	<p>Letter from employer for whom the paycheck stubs do not carry the employee's address</p>
<p>Employer Proof of Withholding of District of Columbia</p>	<p>Employer proof of withholding of District of Columbia taxes for employees who reside with the employer</p>
