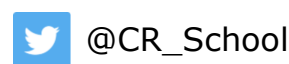

List of Documents to Prove You Live in Washington, DC

ALL documents must include the applicant's name and current DC home address

ONE (1) ORIGINAL of the following items	
A. Pay Stub	<p style="text-align: center;">Document Must Include:</p> <ul style="list-style-type: none"> -DC tax withholding for current tax year -Dated within the past 45 days
B. Unexpired letter confirming Financial Assistance from the DC Government Ex. TANF, Medicaid, DC Alliance, Supplemental Security Income	<ul style="list-style-type: none"> -Issued within the past 12 months
C. Certified copy of DC Tax Form D40	<ul style="list-style-type: none"> -Certified by DC Office of Tax and Revenue -Evidence of payment of DC taxes for the current or most recent tax year
D. Embassy Letter proving the applicant lives on embassy property or will reside on DC property confirmed by the embassy	<ul style="list-style-type: none"> -Issued within the past 12 months -Embassy address -Official embassy seal
OR TWO (2) ORIGINALS of the following:	
E. Unexpired DC motor vehicle registration	
F. Unexpired lease or rental agreement and receipt	<ul style="list-style-type: none"> -Receipt of payment indicating payment of rent within the past 2 months
G. Unexpired DC driver's license or other official DC ID	
H. One utility bill and receipt (only gas, electric, and water bills are acceptable)	<ul style="list-style-type: none"> -Receipt of payment indicating payment for the utility bill within the past 2 months
