- ☑ For career training, GED and Citizenship, complete advising sessions and additional tests.

## Applicants must bring the following in order to apply:

- DC Residency documents (See below)
- Official unexpired government ID (Passport or DC driver's license)

## List of Documents to Prove You Live in Washington, DC

**ALL documents must include the applicant's name and current DC home address**

### ONE (1) ORIGINAL of the following items

	Document Must Include
A. Pay Stub	<ul style="list-style-type: none"> <li>• DC tax withholding for current tax year</li> <li>• Dated within the past 45 days</li> </ul>
B. Unexpired letter confirming financial assistance from the DC Government Ex. TANF, Medicaid, DC Alliance, Supplemental Security Income	<ul style="list-style-type: none"> <li>• Issued within the past 12 months</li> </ul>
C. Certified copy of Tax Form D40	<ul style="list-style-type: none"> <li>• Certified by DC Office of Tax and Revenue</li> <li>• Evidence of payment of DC taxes for the current or most recent tax year (2018)</li> </ul>
D. Embassy Letter to prove the applicant lives on embassy property or will reside on DC property confirmed by the embassy	<ul style="list-style-type: none"> <li>• Issued within the past 12 months</li> <li>• Embassy address</li> <li>• Official embassy seal</li> </ul>

## OR

### TWO (2) ORIGINALS of the following:

E. Unexpired DC motor vehicle registration	
F. Unexpired lease or rental agreement and receipt	<ul style="list-style-type: none"> <li>• Receipt of payment of rent within the past 2 months</li> </ul>
G. Unexpired DC driver's license or other official DC ID	
H. One utility bill and one receipt (Only gas, electric and water bills are acceptable)	<ul style="list-style-type: none"> <li>• Receipt of payment for the utility bill within the past 2 months</li> </ul>
