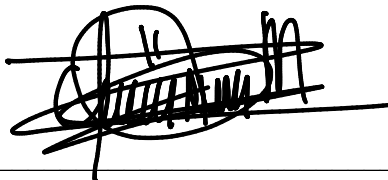
Mr. Torres thanked everyone for a robust discussion during the closed session.
